# 16:00 – 18:00/ Session I: Housing crisis: Ownership and the nature of the problem

In most countries and cities, the geography of home ownership is changing radically. Neoliberal politics have led to the privatization of public space and housing. Gentrification, rent increases, social exclusion are some of the consequences. Apart from private ownership, many cities and towns still have considerable public, cooperative or non-profit housing stocks, which must be defended and expanded if citizens want to take back their cities. An important issue is to determine where power to transform our cities lies. Clearly, there is a diverse list of powerful players including banks, investment funds, small and large landlords. There is also the state, national and local, with several instruments at its disposal, but which is often weak against powerful private interests or actually in collusion with those interests.

In other words, who owns our cities: a matter not just of ownership structure but also access to data collection and instruments of regulation? Are there strategies and concepts for how to return the cities back to their citizens?

### 19:00 – 21:00/ Session II: Lessons from housing movements

The financialisation of rents has triggered a cycle of urban struggles and conflicts in Europe that pose the question of the urban space, raising the issue of its common and collective aspects. While the precarity of labour and survival wage regimes certainly do not facilitate mobilisation processes, the neo-liberal 'governance' of the city has favoured a general repoliticisation of the urban question. This is not only expressed in struggles for housing, but also those for public services and social spaces. This is stronger where, as in Germany, there is a tradition of popular struggles for the right to housing in Greece today? Are there broader perspectives, which starting from the various forms of resistance in the neo-liberal city, pose the question of inequalities and the historical meeting of old and new inequalities?
